**Australian Securities and Investments Commission
Corporations Act 2001 — Paragraphs 601QA(1)(a) and 911A(2)(l) — Exemption**

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraphs 601QA(1)(a) and 911A(2)(l) of the *Corporations Act 2001 (the Act)*.

Title

2. This instrument is ASIC instrument 17-0142.

Commencement

3. This instrument commences on the date of its gazettal.

Exemptions

4. PIPRC Limited ACN 620 744 792 (*the Operator*) does not have to comply with section 601ED of the Act in relation to the operation of the time-sharing scheme known as the Phillip Island Private Residence Club, Phillip Island Road, Cowes, Victoria 3922 Australia (*the Scheme*).
5. The Operator does not have to comply with the requirement to hold an Australian financial services licence for dealing in and giving financial product advice in relation to the resale of interests in the Scheme.

Circumstances to which the exemptions apply

6. The exemptions in paragraphs 4 and 5 are only available where all of the following applies:
 - (a) at least 90% of the votes that may be cast on a resolution by members of the Operator are held by members that are not, and are not associated in relation to the Scheme with, any operator, manager, promoter or developer in relation to the Scheme, other than where held by members solely in their capacity as an associate of the Operator;
 - (b) at least 90% by value or number of all the interests in the Scheme that can be issued have been issued and are held by persons who are not, and are not associated in relation to the Scheme with, any operator, manager, promoter or developer in relation to the Scheme, other than where held by members solely in their capacity as an associate of the Operator;

- (c) the Operator has control over management of the property that members of the Scheme have a right to use, occupy or possess as part of the Scheme (*the Property*) to the exclusion of any responsible entity of the Scheme;
- (d) no responsible entity or former responsible entity of the Scheme operates any scheme under which there is pooling of income received for the use of rights to occupy any part of the Property; and
- (e) all decisions in relation to the operation of the Scheme that materially affect the interests of members may be made only by the Operator or the Operator has a right of veto in relation to such decisions.

Conditions***Exemption from registration***

7. The Operator that relies on the exemption in paragraph 4 must comply with the conditions in paragraphs 8 to 18.
8. In relation to each building that was to be built under the terms of any product disclosure document in relation to the Scheme the Operator:
 - (a) ensures that the building is substantially completed to the extent that members will not be materially affected if no further construction occurs; or
 - (b) gives ASIC a notice in writing stating that the building will not be substantially completed and that the members of the Scheme will not be materially affected by its not being substantially completed;
9. Where any offers of interests in the Scheme for issue or sale are made by the Operator or by any other operator, manager, promoter or developer in relation to the Scheme, and the Scheme is not registered, the Operator ensures that:
 - (a) Chapter 7.9 of the Act is complied with as far as practicable;
 - (b) the offeror holds a Australian financial services licence that contains conditions relating to sales of interests in time-sharing schemes; and
 - (c) the offeror complies with the conditions of the licence, as if the Scheme were a registered scheme;other than an offer of interests referred to in paragraphs 20 to 30.
10. The Operator must ensure that either:
 - (a) the Property is held on trust for the members; or
 - (b) members hold title to the Property, and all members:
 - (i) have received their share or membership certificates in the Operator; and

- (ii) fall into one or more of the following categories:
 - (A) they have received a certificate of title showing the member as holding title in a portion of the Property in accordance with their entitlement (and where there is no certificate of title issued by the relevant titles registry, a copy of a registration confirmation statement or other evidence of title issued by the relevant titles registry); or
 - (B) they have received a copy of the certificate of title certified as a true copy by a Justice of the Peace or a lawyer, where the Operator has acknowledged that it is holding such a certificate in safe custody to be dealt with in accordance with provisions in the Operator's constitution that provide for the certificate to be used only to facilitate a transfer authorised by the member, or on forfeiture of the interest; or
 - (C) they became members as a result of an offer made before 6 December 1999 that was consequent upon the forfeiture of an interest by a former member;
- 11. The Operator must ensure that any management agreement for the Scheme or relating to the Property provides for the dismissal of the manager without any additional payment when members of the Operator pass a resolution to that effect in at least one of the following cases:
 - (a) more than 50% of all members vote for dismissal;
 - (b) members holding more than 50% by value of the interests vote for dismissal;
 - (c) 75% of members voting (whether in person or by proxy) vote for dismissal where at least 25% of members eligible to vote do so; or
 - (d) members holding 75% by value of the interests that are held by members voting (whether in person or by proxy) vote for dismissal where members holding at least 25% by value of the interests eligible to vote do so;
- 12. All expenditure by the Operator in relation to the Scheme must be made in compliance with a budget which sets out all estimated expenditure with reasonable particularity and which has been approved by the directors of the Operator prior to such expenditure being incurred;
- 13. The Operator must give a copy of the budget for a financial year approved by the directors to members with the notice of the annual general meeting of the Operator that occurs in that financial year, together with a statement specifying any changes that were made to any budget that had previously been given to members;
- 14. The Operator must maintain or causes to be maintained an account designated as a trust account into which all gross income of the Scheme must be paid to be held on trust for members and the Operator must ensure that money is disbursed from the account in accordance with its duties to members of the Scheme;

15. The Operator must cause the trust account to be audited by a registered company auditor at least once every 6 months; and
16. The Operator must give a copy of the auditor's report to all members within 3 months after each audit.
17. The operator complies with section 1017D of the Act as if the Scheme was registered.
18. The Operator of the Scheme establishes and maintains an adequate internal dispute resolution procedure:
 - (a) in accordance with subparagraph 912A(2)(a)(i) of the Act as if the Operator were a licensee that was subject to that subparagraph; and
 - (b) that covers complaints against the Operator made by members in connection with the operation of the Scheme.
19. The Operator cannot rely on the exemption in paragraph 4 if the Operator has not complied with the conditions in paragraphs 8 to 18.

Exemption for resale of interests


20. The Operator that relies on the exemption in paragraph 5 must comply with the conditions in paragraphs 21 to 29.
21. The Operator does not sell more than 5% of the interests in the Scheme in one calendar year.
22. The Operator must ensure that any application for an interest in the Scheme is voidable at the option of the applicant during a period of:
 - (a) if the Operator is a member of ATHOC and has not been notified in writing by ASIC that it cannot continue to give a cooling-off period of 7 calendar days not less than 7 days; or
 - (b) otherwise not less than 14 calendar days,

commencing on the date on which the applicant acknowledged receipt of any required disclosure document and the cooling-off statement referred to in paragraph 24 of this Schedule.
23. The Operator must not resell any interest in the Scheme, unless the applicant has provided the acknowledgment of receipt referred to in paragraph 22.
24. Each application form relating to an interest in the Scheme must be accompanied by a separate statement in a form approved by ASIC which:
 - (a) describes the effect of the cooling-off period referred to in paragraph 22; and

- (b) states that the signed application form will be of no effect unless the applicant also signs an acknowledgement of receipt of such a cooling-off statement.
25. The cooling-off rights referred to in paragraph 22 must be disclosed prominently in any required disclosure document and the application form which relate to the offer of interests in the Scheme.
26. The Operator must maintain written records relating to the issue by it of all cooling-off statements referred to in paragraph 24, which include:
- (a) each applicant's signed acknowledgement of receipt of such a statement; and
 - (b) the date of issue of each statement; and
 - (c) the identity of the applicant to whom each statement has been issued.
27. The Operator must return the deposit for an interest in the Scheme, and must not deduct any fees or expenses, if the applicant decides not to proceed with the purchase of an interest in the Scheme during the cooling-off period referred to in paragraph 22.
28. If the Operator receives a deposit for an interest in the Scheme, it must:
- (a) pay, by the next business day, the deposit into an account that is held with an Australian ADI into which only deposit monies from an application for the purchase of an interest in the Scheme and interest on those deposit monies are paid; and
 - (b) hold the deposit on trust for the applicant until the cooling-off period in paragraph 22 has expired.
29. The Operator establishes and maintains membership of an external dispute resolution scheme:
- (a) in accordance with subparagraph 912A(2)(b)(i) of the Act as if the Operator were a licensee that was subject to that subparagraph; and
 - (b) that covers complaints against the Operator made by members in connection with the operation of the Scheme.
30. The Operator cannot rely on the exemption in paragraph 5 if the Operator has not complied with the conditions in paragraph 21 to 29.

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraph 741(1) of the *Corporations Act 2001 (Act)*.

Title

2. This instrument is ASIC instrument 17-0797.

Commencement

3. This instrument commences on the date it is signed.

Declaration

4. Chapter 6D of the Act applies to Namoi Cotton Co-operative Ltd ARBN 010 485 588 (*Namoi Cotton*) as if subsections 711(6) and 723(1) of the Act were omitted.
5. Chapter 6D of the Act applies to Namoi Cotton as if subparagraph 734(5)(b)(iii) and paragraph 734(6)(e) of the Act were omitted.

Where this instrument applies

6. The declaration in paragraph 4 applies in relation to an offer of ordinary shares in Namoi Cotton under a prospectus lodged with ASIC in substantially the form provided to ASIC on 25 August 2017 where:
 - a) the offer is made to former Grower Members who, pursuant to the Co-operatives National Law, are entitled to participate in the Proposal on paying to Namoi Cotton the amount they were repaid by Namoi Cotton when their holding of Grower Shares was forfeited;
 - b) the prospectus contains a statement that no ordinary shares will be issued on the basis of the prospectus after 31 October 2017; and
 - c) the prospectus is accompanied by the Explanatory Memorandum.
7. The declaration in paragraph 5 applies in relation to an advertisement or publication that directly or indirectly refers to an offer or proposed offer of ordinary shares in Namoi Cotton as part of the Proposal where a prospectus is lodged or will be lodged in relation to the offer.

Interpretation

8. In this instrument:

Co-operatives National Law means the Co-operatives National Law (NSW), set out as the appendix to the *Co-operatives (Adoption of National Law) Act 2012 (NSW)*.

Explanatory Memorandum means the disclosure statement and explanatory statement (including prospectus) and notices of meeting and notices of postal ballots dated 16 August 2017 and sent to holders of Grower Shares and Namoi Capital Stock in Namoi Cotton in relation to the Proposal.

Grower Shares means a fully paid ordinary share in Namoi Cotton, having the rights conferred on Grower Shares by the rules of Namoi Cotton.

Namoi Capital Stock means a co-operative capital unit (referred to as a CCU in the Co-operatives National Law) in the capital of Namoi Cotton, having the rights conferred on Namoi Capital Stock by the rules of Namoi Cotton.

Proposal means the arrangement under which Namoi Cotton proposes to restructure its corporate and capital structure involving, among other things, the variation of Grower Shares and Namoi Capital Stock rights and schemes of arrangement under the Co-operatives National Law, where the arrangement is approved by resolutions passed by postal ballots of holders of Grower Shares and at meetings of the holders of Namoi Capital Stock, respectively.

4. BetaShares Capital Ltd ACN 139 566 868 (*responsible entity*) in its capacity as the responsible entity of the BetaShares Active Australian Hybrids Fund ARSN 613 694 009 (the *Scheme*) does not have to comply with section 1017B of the Act for as long as the conditions in paragraph 6 are met.

Where this exemption applies

5. The exemption in paragraph 4 applies where the Scheme is an AQUA Managed Fund and interests in the Scheme remain admitted to Trading Status as a Managed Fund Product.

Conditions

6. The responsible entity must:
 - (a) comply with section 675 of the Act as if the Scheme were an unlisted disclosing entity; and
 - (b) include statements in any Product Disclosure Statement for the interests in the Scheme to the effect that the responsible entity will comply with the continuous disclosure requirements of the Act as if the Scheme were an unlisted disclosing entity.
